Entering the flat on the second floor, you step into an entrance hall that flows through to the impressive reception room. This exceptionally spacious double-length room measures over 34 feet, filled with light from large windows. The space accommodates both seating and dining areas, featuring elegant built-in white shelving, providing useful storage space.

The separate eat-in kitchen is fitted with built in units with integrated appliances and ample storage completing the functional layout.



The Bedrooms

Both bedrooms feature large windows and fitted wardrobes providing generous storage. The principal bedroom benefits from an ensuite bathroom, while a separate shower room serves the second bedroom.



The Neighbourhood

Swan Court is a distinguished brick building moments away from the King's Road and Sloane Square.
